Our organization consists of Firefighters, Police Officers and EMS personnel who ride BICYCLES to Honor emergency first responders who have died in the line of duty. Our mission is to provide emotional and financial support for their families who are left behind.

Over the past fifteen years, we have honored the memory and sacrifice of 707 Emergency First Responders which includes; firefighters, law enforcement officers and emergency medical personnel. Our team has traveled on bicycles over 12,000 miles, through sixteen states.

Through year-round fundraising efforts, the Brotherhood Ride has been able to honor the memory of our fallen heroes and provide emotional and financial support to their families. During our past Brotherhood Rides, we have honored our fallen brothers and sisters from SC, TX, NY, FL, TN, PA, NJ, CT and MA and we are very proud to have donated over \$840,000.00 to the families left behind.

Our 2023 Ride, will be dedicated to 28 Florida Fallen Heroes who died in the line of duty in 2022 while protecting their communities. Beginning October 27th from Naples, our team will honor them by cycling through the state of Florida for 9 days, covering over 600 miles and average 70-90 miles a day. The ride will conclude on November 4th in Miami.

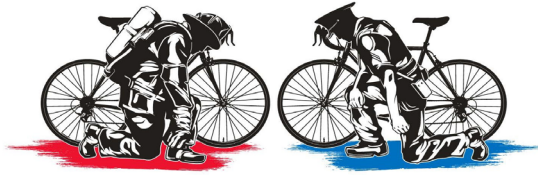

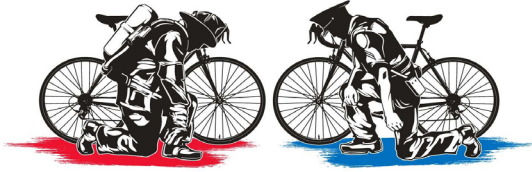
